



Korian strengthens its presence in Italy with the acquisition of the Sanem group in Rome

Milan, June 20, 2019. The Korian Group, an expert in care and support services for the elderly, announces the acquisition in Italy of Sanem Group, a group of four outpatient diagnostic and testing centres in Rome. These facilities offer private and accredited health care services including ambulatory medical rehabilitation, radiology, testing and specialized ambulatory services. The four centres (Delle Valli, Serenissima, Medical House Vigne Nuove and Sanem 2001) receive about 100,000 patients each year.

A new step to consolidate Korian's leadership in Italy

This acquisition allows Korian to expand its offer in Italy, which now includes 41 retirement homes, seven daycare centres and 124 apartments of service residences, 16 institutions specializing in the reception of people with Alzheimer's disease, ten nursing homes and rehabilitation clinics, nine clinics, four psychiatric homes, three acute care services, three residential centres and three night shelters for people with disabilities, one palliative care centre and six home care agencies, representing approximately 6,000 beds, for 300,000 patients.

These centres meet Korian quality standards in terms of level of care and patient reception conditions. In addition, their multidisciplinary healthcare teams work according to a method that places the patient at the heart of their organization, in order to offer personalized care adapted to the needs of each of them, in line with Korian's "Positive Care" approach.

With this new acquisition, followed by Bc&Milano as legal and financial advisor for Korian and Deloitte as financial and legal advisor for the vendors, Korian is strengthening its presence in Rome, where the four centres will be attached to the San Giuseppe retirement home and specialized clinic.

Mariuccia Rossini, Managing Director of Korian Italy, said: *"I am very proud to announce the acquisition of these four outpatient centres, known in Rome for their highly qualified healthcare staff and advanced services. Korian is thus offering ever more services to the inhabitants of Rome and continues to strengthen its network of quality establishments in Italy"*.
